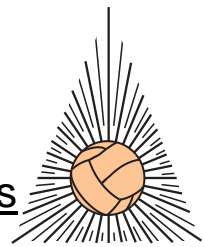


TRIAL & DEVELOPMENT SESSIONS

Perth Netball Association (Inc) will be conducting Trials for 13&U, 14&U and 15&U for selection in **both** the Development and the Smarter than Smoking Association Championship representative teams. **You will be expected to commit to ALL Development Sessions, Championship Training Sessions and be available for three days of competition over the June Long Weekend.**

Note: the 12 & Under squads have already been selected and players will be sent out information in February.

- 14 & Under/ 15 & Under, 6.15pm-8.00pm

Cost is \$10 for both Trial Sessions. All players must attend both sessions.

Eligibility: All players MUST be affiliated with a PNA club.

On completion of the Trial Sessions, players will be selected for Development in each age group and names will be posted on our website (www.perthnetball.com.au) under the "coaching" page by the close of business, Friday 24th February.
